# **Chapter Abstract**

In this chapter we distill some of the lessons we have learned over the past 20 years in promoting integrity and confronting corruption. How can we better live up to our moral and ethical aspirations? As both Christians and psychologists, we reflect on the nature of integrity and corruption, highlighting the challenges and tactics of dysfunction, deviance, and self-deception (part one). We then feature 10 materials that have been developed within the Lausanne Movement (2010-2020), noting the importance of using and building upon these foundational resources (part two). We conclude with a summons to the international church-mission community (CMC) to resolutely and broadly collaborate towards a global integrity movement, marked by righteousness and relevance, and includes a link-list of multi-sectoral resources for integrity and anti-corruption. We are the light—or the darkness—of the world.
