The focus is on the mission sector with applications for/from the overlapping health, development, humanitarian, and other sectors.

Rather, it is the missiological equivalent of “the average person on the street”—the missionary on the field. Herein lies the backbone and the future of member care: mutual support and spiritual nurture among missionaries, and between missionaries and the people to whom they are called. We member care workers primarily polish the gold that is already there. May God give us grace to follow their examples of sacrifice. And may we do our part in supporting them in their most holy work, serving with them unto the ends of the earth and until the end of the age.”
